

## Indictment 2 (C11434997.4) **Charge 1.**

### **STOLEN MONEY FROM LAVERTON ARMED ROBBERY**

**“ALL EVIDENCE VANISHES INTO THIN AIR” “IN POSSESSION OF DEFENCE COUNSEL!”**

**Gavin Green was my legal aid appointed advocate at the time representing me.**

Authorised to collect a bundle of **“intercepted by the jail”**, following his legal visit.”

This legal visit took place on the 20<sup>th</sup> November 2013.

He was in company of Saul Holt at the time.

I had Acacia Unit Barwon Prison Chief Mr Gary Collinson draft up a document for Gavin Green to sign and date on receiving large bundle of my mail.

This document was written in Mr Collinsons own hand writing.

I was allowed some (5) letters copied of the (96) for my own use, which were not deemed offensive.

**I had argued this very point with Chief Mr Collinson, who I had asked to witness a receipt of all mail collected by Gavin Green, signed and dated by Gavin Green.**

These very same letters **“exonerating me”** in **“addressing the un-accounted for” monies stolen from Laverton armed robbery.**

Were later to **“GO MISSING!”**

**All traces of their existence and their contents evidentiary value is now evaporated into thin air!**

**Real good reliable trusted legal team indeed!**

**Mail to Loretta Collier dated 12/06/2012. Was a part of overall (96) other mail.**

Where I had told them last known whereabouts of stolen monies from robbery.

That I had requested to have a copy of a letter addressed to "Loretta Collier dated
