**Page 151 L19 -24 Mr Holt:** I can now refer you to the shots out the back specifically, which we just observed. I won't make submissions in the depth I had intended to because much of this was covered in the next stage between your Honour and my learned friend yesterday, and I'll simply refer to it.

**Page 152 L19 -23 Mr Holt:** The first bullet of course hits that low wall, the third bullet isn't ever recovered and goes through a fence that is unrelated. And importantly, I won't trouble your Honour with the detail of this because you were taken through this with some care yesterday.

At the time of the shots being fired, SOG Operator 55 was positioned on the north-east rear corner of the property. **One bullet struck the low brick retaining wall and has not been recovered,<sup>21</sup>.**

Page 197 L2- 4 Mr Chadwick: **Another bullet passed through the side fence and has also not been recovered,** After the shots were fire, SOG Operator 55 observed that the third bullet had penetrated the back fence and continued through the sound barrier fence. That bullet was later recovered from the road reserve of Keilor Park Drive.<sup>21</sup>.

Page 197 L17 -18 Mr Chatwick **"Yes, the corner closest to the pylon. Yes, the lower corner in the photo"**.

Page 197 L19 - His Honour: **"Yes, alright on the right?"**

Page 197 L20 Mr Chatwick: **"Thats the one"**.

Page 197 L21 His Honour: **Okay.**<sup>21</sup>.

The following morning at about 10.09am I was viewing the monitor along with operator 131. I observed the security door open and a males arm holding a silver coloured revolver appear from behind the open security door. The male fired three shots in a northerly direction towards Keilor Park Drive. Keilor Park Drive is a busy thoroughfare and at this time traffic was quite heavy. **After a short time I moved to the property fence line where I observed a small hole made by the hand gun round. The location of the hole was about 3 metres to the west of the floodlight.** I followed the trajectory of the round to the Barrier fence bordering Keilor Park Drive where I further observed a small hole where the round had penetrated the barrier fence and onto Keilor Parl Drive. I maintained my position till about 2.30pm.<sup>92</sup>.

**POLICE S.O.G. OPERATOR (55) EVIDENCE 264 L30-265 L9.**
